We understand that you are busy, that general practice is underfunded and asking you to do extra work that is not in your contract is neither possible nor respectful. As with any service we expect to remunerate you for your time. We respect that if you are asked to do work that is outside of your contract that you need to be funded to provide this service.

#### REMUNERATION

We have liaised with your fellow GPs to agree an appropriate fee for the additional work that you will be expected to carry out on behalf of your patients. Each case will be evaluated on an individual basis but be under no illusion we value your time and the work involved in making sure your patients receive the best of care.

#### **DIAGNOSTICS**

When sending patients to one of our hospitals that are fully accredited and have been inspected by Irish GPs, patients need a number of diagnostics. Diagnostics needed: A recent blood test, ECG, X Ray, MRSI swabs, MRI, We also require a referral letter for the receiving consultant.

Other than this you will see the patient as you would in your normal day to day care as a health care professional, you will be asked to liaise with our patient advisor from Surgery Now to ensure the smooth logistics for your patient before and post-surgery.

#### PATIENT PATHWAY



#### Step 1



#### Step 2

You or your patient will get in touch with Surgery Now for support with the process of getting treatment abroad.



#### Step 3

We will send an information pack to the patient to get things started.



#### Step 4

We will identify the most appropriate hospital for the treatment.



#### Step 5

You will organise for your patient to have some diagnostic tests e.g. swabs, ECG, blood tests, x-ray etc... in advance of your patient



#### Step 6

We will liaise with the chosen hospital to get surgery dates arranged



#### Step 7

Once the date is confirmed we arrange travel, accommodation and transfers to and from the airport on behalf of your patient.



#### Step 8

Your patient is now ready to travel. Once they arrive at the hospital they will have an out-patient appointment with the consultant the day before they receive their treatment.
